any person committing a felony or breach of the peace in his presence.

2. The Sheriff and

3. The Coroner may apprehend any felon within the County without warrant."

We do not desire to go the whole length of this authority, which shows (by implication) that the Sheriff could not make arrest for a breach of the peace without a warrant in any case. It is enough for us that he clearly cannot do so when the breach is not committed in his presence, and that the facts in this case show no breach te have been thus committed. We refer " Observer " to 1 Chitty, 186, to show what might be done with the Sheriff in this case, if it were not +vident that the mistake he made was unintentional .-It is perfectly obvious that nothing need be said to acquit Justice Sackett of any blame for his decision.-Though a Western man, he appears to have decided against his sympathies, because bound by his oath of office. Indeed, the subject had subsided to a state of perfect quiet and repose in the public mind until the indiscreet attempt of "Observer" strove to rekindle the flames of excitement. We do not think the at-tempt will be successful. For while public opinion maintains its present moderation and calmness, the designs of the demagogue and the turbulence of the agitator will strive vainly to lash its placid surface CRITO. into storms.

Mr. Editor :- Less than two months since, a deep interest was evinced by the people of this city, on the subject of a Levee. This feeling was responded to by the Common Council, in the constitutional mode, by submitting to the people a proposition embodying an appropriation deemed sufficient to effect the object. And what was the response ? A vote nearly unanimous in favor of it, and which a conviction as universal as the belief of its necessity, only prevented from being in number nearly equal to the population qualified to vote on it.

Since the return of the vote to the Council, the subject has been allowed to go quietly to sleep, and months are rapidly passing away in which labor can be procured at a reasonable price, and the ground is in a state favorable to the most profitable disposition of the labor. But we are constantly reminded, by an honorable member of the Council, -equally distinguished for his talents and his eccentric mode of displaying them,-that the only danger is, too much haste on the part of the Council in its legislative proceedings. And this axiom it seems disposed to adopt as its rule of action. But, sincerely, is our protection from another overflow to depend upon the energy of an individual ? And shall the proper season for the erection of this work pass away, and our Council and people be forced to add to the obligations we Low owe our enterprising Mayor ? S

MEETING OF THE COMMON COUNCIL.-Tuesday Evening, May 28th .- Ordinance for removal of obstructions in the streets and public places, and to prevent unlawful and injurious practices in the city. Considered and referred to committee on streets and public places.

On motion of Ald. Tweed, the captain of the city watch was authorized in conjunction with the city marshal to provide a proper building for a watch Ald, McKenzie reported an ordinance creahouse. ting and defining the duties of a chief engineer. Re-ferred to special committee. On motion of Ald. Tweed it was resolved that the committee on old claims be requested to hold their session at some convenient place, giving due notice of it and the time of meeting, in at least one of the papers published in the city, and that said notice shall call for the immediate presentation of all claims contracted by the late city council; and having examined each claim, report to this body their opinion as to its allowance; and that said committee receive \$25 per day while engaged in examination of claims.

The president reported an ordinance prescribing the manner and form of procedure, in regulating, improving or repairing any street, alley or public place. Also an ordinance creating and defining the duties of conncil clerk, which was adopted.

Ald. Queen gave notice he would introduce at the next meeting an ordinance for licensing auctioneers,

> · Diggings' and · Diggers.' STRAFFORD BAR,

North Fork, May 25, 1850. On Saturday last I wrote you that the weather was very hot and river high. The past week has been much cooler, and the water has been falling since Sunday, and is now quite low, yet not sufficiently so as to allow the miners to go on with their work to any advantage

On Wednesday a party of men were out some five or six miles from the miles from the river in search of deer, when they suddenly came upon a body of In-dians, 200 in number, they say. They made the best of their way back to camp, without being seen by them ; and the next morning they, with some others, went is search, intending to give them battle. They spent most of the day without seeing any of them, and they separated. On their way home, five of them came upon a few Indians, and fired upon them before they were seen. The Indians ran, leaving five dead upon the field and one squaw, who was too much frightened to run. She, with a year old boy, were taken prisoners and brought into camp at about sun-The squaw seemed quite contented with her down. condition, no doubt thinking it preferable to being shot, as her companions were. She is the worst looking specimen of human nature that I have seen yet -far worse than the same tribe in the Southern mines -her hair filled with pitch and sand and nearly naked, covered only with a piece of blanket .--The party who captured her removed her to their tent, fed her well and gave her a blanket. The next morning she asked if she might "vamos." They told her yes, and she backed her boy and made tracks over the hill in a very quiet, sober way, as if she had entirely overcome her foars of the white men. I fear there will be trouble yet in this quarter of a serious nature, for the Indian and the white man cannot well ive together; they seem to be, at least in this part of the country, sworn foes, kill each other wherever they meet. I suppose this will prove quite a long enough letter from this quarter. J C. W.
