Section 8026 of the California Health and Safety Code requires the Native American Heritage Commission (NAHC) to nominate members to the University of California (UC) systemwide and campus Native American Graves Protection and Repatriation Act Oversight Committees. The NAHC has created a nomination subcommittee for this purpose.

The NAHC nomination subcommittee shall review nominations and provide final qualifying nominations with preferences to the University of California regents or the regents' designee.

- (iv) A list of at least three references, with names, telephone numbers, and email addresses for each.

Tribal Nominees: Support letters or tribal resolutions for tribal nominees should be from Tribal governments, tribal community organizations or Institutional leadership organizations, include the strengths of the candidate, as well as any information that might be relevant to the NAHC reviewing committee.

Incomplete packets will not be considered by the nomination subcommittee.

Within fourteen (14) days of the NAHC's receipt of notice that the UC seeks to establish a systemwide or campus committee, NAHC staff shall publish nomination materials on the NAHC website and provide notice to the NAHC contact list, tribal communities and interested stakeholders. The nomination period shall remain open for no less than forty-five (45) days. The nomination subcommittee shall endeavor to provide all qualifying nominations with preferences to the University of California regents or the regents' designee within forty-five (45) days of the close of the nomination period.
