Re: Nomination of Laruen Peters to UC Systemwide Committee

I. INTRODUCTION

This memorandum memorializes the recommendation of the Commission's UC Nominations Subcommittee to nominate Ms. Lauren Peters to the UC systemwide committee (as a non-voting representative from UC Davis). The Subcommittee believes Ms. Peters is qualified to serve and refers the final decision to the Commission. At the last Commission meeting on July 15, 2022, the Commissioners expressed a desire to nominate Ms. Peters after clarifying her interest in a non-voting position specifically. Both Executive Secretary Raymond C. Hitchcock and Deputy Attorney General John Appelbaum spoke with Ms. Peters and confirmed her preference for a non-voting position on the UC systemwide committee.

In addition to recommending Ms. Peters' nomination, this memorandum identifies the current vacancies for both the UC Campus and Systemwide Committees, as well as the efforts made to fill those positions by the UCOP.

II. CURRENT VACANCIES

There are currently the following vacancies on the systemwide and campus committees:

- *Systemwide Vacancies (Non-voting UC Representatives)*
 - UC Berkeley (UC Rep. Non-voting)
 - UC Riverside (UC Rep. Non-voting)
 - UC Santa Barbara (UC Rep. Non-voting)
 - UC Davis (UC Rep. Non-voting): Proposing Lauren Peters
- *Campus Vacancies*
 - UC Riverside (UC Rep.) Matthew Hall and Steven Mandeville-Gamble resigned. Proposing Gerald Clarke and William Clarke-Kidder
 - UC Berkeley (UC Rep.) Beth Piatote resigned. Proposing Seth Davis

- *Temporary Filled Campus Positions*
 - UC Davis (UC Rep.) Anthony Burris is continuing on an interim basis until a qualified candidate applies for his position.

Lourdes Dematto, Director of the UC Office of the President, addressed in an email to NAHC Attorney, Mario Pallari, current and past outreach efforts made to attract qualified candidates to the UC Systemwide and Campus Repatriation Committee. Ms. Demattos first stated that a template provided by the NAHC was sent out on November 27, 2022, to all UC Campus Repatriation Coordinators for dissemination. Additionally, Ms. Demattos stated that a similar outreach had been directed by the UC Office of the President to all campuses with vacancies on their Campus Repatriation Committees.

III. APPROVING THE NOMINATIONS TO THE SYSTEMWIDE COMMITTEE AND UCSB CAMPUS COMMITTEE

The UC Nominations Subcommittee recommends the nomination of Lauren Peters to the UC Systemwide Repatriation Committee (UC Davis non-voting representative). Her application is attached as Exhibit 1, hereto. In brief, Ms. Peters received her Masters from UC Davis in 2022 in Native American Studies with an emphasis on human rights. She is enrolled with the Agdaagux Tribe of King Cove, Alaska. She formerly served on the national NAGPRA Committee under President Obama where she co-wrote the annual Report to Congress and served on the Ethics sub-committee. She is the Alaska Native Advisor at Fort Ross, California where she has organized cross-Tribal and international Indigenous celebrations. Ms. Peters has received many scholarships and awards, including as a research scholar for the Robert Wood Johnson and Mellon Foundations. She has also published one book and many articles on Native American issues, including on repatriation.
