In submitting this Preliminary Inventory to the Commission, the Museum/Agency complied with the following CalNAGPRA requirements:

Identifying Information: Pursuant to Section 8013, subdivision (b)(1)(A), identified the geographical location, cultural affiliation, aboriginal territory, and the circumstances surrounding their acquisition in the inventory.

Consultation on Required Items: Pursuant to Section 8013, subdivision (b)(1)(B), consulted, prior to new or additional inventory work being conducted, with affiliated California Indian tribes on any protocols to be used in the inventory process, including, but not limited to, all of the following:

- (i) Minimizing handling.
- (ii) Using a lot approach with a minimum number of individuals set at one.

(iii) Identifying human remains and associated funerary objects, burial site, or ceremonial items with tribal expertise receiving deference

Clearly Culturally Identifiable

(i) Listed in the preliminary inventory the human remains and associated funerary objects that are clearly identifiable as to state cultural affiliation with California Indian tribes. These human remains and cultural items shall be listed first to expedite the repatriation of these items.

(ii) Utilized Tribal traditional knowledge to establish state cultural affiliation and identify associated funerary objects. As well as recorded any identifications of cultural items that are made by tribal representatives. These identifications may include broad categorical identifications, including, but not limited to, the identification of everything from a burial site as a funerary object.

Not Clearly Identifiable

Pursuant to Section 8013, subdivision (b)(1)(D), listed the human remains and associated funerary objects that are not clearly identifiable by state cultural affiliation but that, given the totality of circumstances surrounding their acquisition and characteristics, including the unique circumstances of California history, are determined by a reasonable belief to be human remains and associated funerary objects with a state cultural affiliation with one or more California Indian tribes. Consulted with California Indian tribes reasonably believed to be culturally affiliated with the items, during the compilation of the preliminary inventory as part of the determination of affiliation.

Not Culturally Affiliated (Aboriginal Territory):

Pursuant to Section 8013, subdivision (b)(1)(D)-(E), if the agency or museum could not determine which California Indian tribes are believed to be culturally affiliated with the items, then the agency or museum in consultation with the commission considered if the items listed in the inventory could be determined by a reasonable belief to have been removed from an area identified as the state aboriginal territory of a California Indian Tribe, given the totality of the circumstances, including the unique circumstances of California history
