

**PROPOSED DRAFT SCHEDULE FOR PROPOSED  
CONTACT LIST REGULATIONS**

(as of December 21, 2022)

January 20, 2023	Commission reviews proposed revised regulations, post version on website and seek public comment.
February- 2023	Commence tribal consultation with at least a 45-day period for tribal consultation, including virtual listening sessions.
March 2023	Summarize comments and make related changes.
March 2023	Submit proposed revised regs to subcommittee for review.
End of March 2023	Submit proposed regs reviewed by subcommittee for CNRA/AG review for legal issues. This may or may be completed before April 21, 2023 Commission meeting.
April 20, 2023	Draft proposed Contact List regulations included on Commission agenda for review and approval. Assuming the Commission elects to move forward with some version of this draft, then the process will continue.
May 2023	Ensure proposed regulations are approved by CNRA/AG. If no, or insubstantial changes are made, the process will continue. If substantive legal changes are made, the proposed regs will go back to Commission for re-approval July 21, 2023.
June 2023	Submit proposed regulations to Department of Finance for fiscal impact assessment. If it proceeds expeditiously, this process takes approximately 30-days.
July-August 2023	Submit rulemaking package (Notice of Proposed Regulatory Action [NOPA], proposed regulation, initial statement of reasons and economic and fiscal impact statement to OAL for publication in the Regulatory Notice Register.
September 2023	Publication of the NOPA in the Regulatory Notice Register, initiating the rulemaking

	process which must be completed in one year (by September 2024).
September 7, 2023	Public comment period begins with a minimum comment period of 45-days.
October 22, 2023	Initial comment period ends.
October-November 2023	Public hearing(s).
November-December 2023	Staff summarizes comments and drafts proposed responses.
January 20, 2024	Commission approves staff's responses to comments and decides whether to revise or finalize proposed regulations.
February 2024 (Contact List Regs potentially become final)	If the Commission does not make substantive changes to proposed regulations, the rulemaking record would be transferred to OAL which has 30-days to review the proposed regulations which take effect on a quarterly basis after OAL approval and submission to the Secretary of State.
February 2024 (If Changes are Made to Regs)	If the Commission makes substantial changes to the proposed regulations, then these would need to be published by OAL and a minimum 15-day review period would be required.
March 2024	Public comment period on proposed changes to the regulations ends.
March 2024	Staff summarizes comments and drafts proposed responses which the Commission adopts including for final proposed regulations.
April 20, 2024	If the Commission does not make substantive changes to proposed regulations, the rulemaking record would be transferred to OAL which has 30-days to review the proposed regulations which take effect on a quarterly basis after OAL approval and submission to the Secretary of State.
May 2024	Regs become final.
June 2024	Regulatory process must be completed or started a new.
