Mr. Dunlap has completed over two hundred projects fulfilling Native American and archaeological monitoring required under CEQA, AB52, SB18 and PRC. 5097.98 consultation. Here at Cal State Long Beach Mr. Dunlap and his team have successfully completed AB275 inventory projects including an analysis of faunal, and human remains, lithics and funerary object analysis and classification. In addition, Sam has sat on the NAGPRA committee at CSULB since 1998.



Whereas; The Gabrielino/Tongva Nation ratified The Constitution of the Gabrielino/Tongva Nation on February 17, 2007 and amended the same on February 22, 2020; **and**

Whereas; The Constitution is the Supreme Law of the Gabrielino/Tongva Nation; **and**

Whereas; Article IV of the Constitution calls for the Peo'tskome (Tribal Council), the elected governing council of the Gabrielino/Tongva Nation, to pass and enact a law for the requirements to run for election and serve as a member of the Peo'tskome; **and**

Whereas; The Gabrielino/Tongva Nation Election Act of 2007 was enacted and revised ten separate instances under the guidance and the power vested in the Peo'tskome pursuant to the Constitution of the Gabrielino/Tongva Nation; **and**

Whereas; The Gabrielino/Tongva Nation Peo'tskome are duly elected through the laws governing the Gabrielino/Tongva Nation; **and**

Whereas; Article V, Section 2F of the Constitution gives the Peo'tskome the power to negotiate or enter into Treaties, Compacts, Contracts, or other Agreements with other governments or other parties on behalf of the Gabrielino/Tongva Nation; **and**

Whereas; Article V, Section 4 of the Constitution gives the Peo'tskome any right or power, heretofore, vested in the Gabrielino/Tongva Nation, but not expressly referred to in the Constitution, shall not be abridged; **and**

Whereas; Article II, Section 2 of the Constitution calls for the Peo'tskome to pass a law creating a Department of Citizenship; **and**

Whereas; The Peo'tskome enacted the Gabrielino/Tongva Nation Citizenship Act of 2009 and amended the same on February 15, 2015; **and**

Whereas; The Department of Citizenship has been processing and enrolling the people with Gabrielino Tongva heritage that choose to enroll with the Gabrielino/Tongva Nation; **and**

Whereas; Samuel Dunlap has applied for and met the criteria for enrollment; **and**


Whereas; The Department of Citizenship after reviewing the documents supporting the claims of Samuel Dunlap, approved and made him a citizen of the Tribe; **and**

Whereas; The Tribal Council Chairwoman has spoken to Samuel Dunlap and reviewed his qualifications to be nominated for the Cal State University Native American Graves Protection and Repatriation Act Implementation and Oversight Committee; **and**




Whereas; Samuel Dunlap has agreed to a commitment of three years if he is appointed through the Cal State University and NAHC appointment process; **now, therefore, be it**




