Overview

Policy

California State University is committed to establishing a Systemwide NAGPRA Committee with repatriation expertise in accordance with the state and federal Native American Graves Protection and Repatriation Acts (NAGPRA and CalNAGPRA).

The California State University (CSU) is committed to fully implementing the spirit as well as the legal requirements of both the Federal Native American Graves Protection and Repatriation Act (NAGPRA) and the California Native American Graves Protection and Repatriation Act (CalNAGPRA), which were enacted to acknowledge the fundamental human right of Native Americans, Alaska Natives, and Native Hawaiians to their ancestral Human Remains and Cultural Items.

Committee Charge

The purpose of the committee is to provide The California State University system with expertise concerning repatriation in accordance with the Native American Graves Protection and Repatriation Act (NAGPRA) and the California Native American Graves Protection and Repatriation Act (CalNAGPRA) and makes recommendations to the Chancellor on matters of compliance and best practices. The committee provides systemwide compliance oversight as well as reviews and promotes implementation of the CSU Systemwide NAGPRA Policy. The committee will establish systemwide directives and guiding principles for all CSU campuses whether or not campuses hold CalNAGPRA/NAGPRA collections. The CSU is referencing the requirements as outlined in Assembly Bill 389 Section 8028.7 and Section 8028.71 to guide the committee selection and policy development processes.

The CSU Systemwide NAGPRA Committee ("Committee" herein) is an advisory committee to the Chancellor to:

- Ensure that campuses within the CSU system are compliant with the state and federal NAGPRA laws;
- Monitor repatriation process and activities of all CSU campuses; and
- Ensure repatriation to Tribes is made in a timely manner through meaningful consultations.

The Committee provides an opportunity to educate administrators, faculty, staff, and students on state and federal NAGPRA laws and CSU responsibility to Tribal communities to ensure the Native American ancestral remains and cultural items are repatriated with dignity and respect.

Committee Membership

There shall be a total of seven voting members and one non-voting member. Of these, four voting members shall be from an Indian Tribe, and three voting members shall be from the

California State University. There shall be a non-voting member from each CSU campus. At least a majority of the Committee's voting members shall be from California Indian Tribes. The membership of the committee shall be as follows per Assembly Bill 389 Section 8028.71:

Three voting members of an Indian Tribe as described paragraph (1) of subdivision (c) of Section 8012, meeting the requirements of subdivision (c) of this section.

One voting member of an Indian Tribe as described in paragraph (2) of subdivision (c) of Section 8012, meeting the requirements of subdivision (c) of this section, or, if none is available, a member of an Indian Tribe as described in paragraph (1) of subdivision (c) of Section 8012, meeting the requirements of subdivision (c) of this section.

Three voting members from the California State University. At least two of these members shall be affiliated with an American Indian or Native American studies program and each of these members shall meet the requirements of subdivision (d).

One nonvoting member from each campus of the California State University that is subject to the federal Native American Graves Protection and Repatriation Act (25 U.S.C. Sec. 3001 et seq.). Each of these nonvoting members shall meet the requirements of subdivision (d).

The composition of the systemwide committee may be altered to include a greater number of qualified members of a California Indian Tribe, to the extent that qualified California State University candidates cannot be located pursuant to paragraph (2).

Tribal Members

Tribal members must be a member of a federally or non-federally recognized California Indian Tribe as defined by Section 8012 of the Health and Safety Code. Committee members shall have preferred experience in any of the following:

- Tribal Historic Preservation Officer work;
- Repatriation of human remains and cultural items pursuant to CalNAGPRA/NAGPRA;
- Cultural resources protection under Tribal, state, and federal law; or
- Consultation with state and federal entities and agencies.

Preference shall be given to members of a California Indian Tribe. If no members of a California Indian Tribe meeting the qualifications of 8028.71 subdivision (c) paragraph (1) are available, members of other Tribes may serve.

CSU Staff/Faculty Members

CSU Staff/Faculty members must be affiliated with or employed by the California State University and have the following:

- A graduate degree in any of the following: Archaeology, Anthropology, Native American Studies, Ethnic Studies, Law, Sociology, Social Sciences, Environmental Studies, or History, with a focus in California;
 - If there are no candidates satisfying this clause, candidates that have degrees and direct professional experience in fields relevant to repatriation or tribal cultural resources matters shall be deemed to meet

the clause; and

• A minimum of five years' experience working in his or her field of study.

Preference shall be given to members who have demonstrated, through their professional experience, the ability to work in collaboration with Native American tribes successfully on issues related to repatriation or museum collection management.

Appointments

The Chancellor of the California State University, or the Chancellor's designee, shall appoint members to the Committee upon nomination by the California Native American Heritage Commission.

<u>Term</u>

Members will serve three-year staggered terms with the ability to continue consecutive terms.

Compensation

Travel expenses will be reimbursed in accord with the CSU Systemwide Travel and Business Expense Payments Policy: https://calstate.policystat.com/policy/14534868/latest/?showchanges=true

<u>Meetings</u>

The Committee will meet quarterly within the academic year and as needed to comply with timely repatriation efforts to the Tribes.

Officer Positions

Chairperson: The Committee will be chaired by a member elected by the Committee from its membership, every three years.

Vice Chairperson: Chairperson shall elect this position.

Secretary: A secretary will be assigned by the Office of the Chancellor.

WHEREAS, the Santa Rosa Rancheria Tachi Yokut Tribe is dedicated to the preservation and protection of cultural resources associated with traditional values and beliefs important to the Tachi Yokut cultural and of preservation of the physical sites, location, and context in which those resources are found; and

WHEREAS, the Santa Rosa Rancheria is dedicated to the protection and repatriation of their ancestral remains, funerary items, sacred items, and items of cultural patrimony; and

WHEREAS, the Tribe is determined to assist the California State Universities to repatriate all Native American Ancestral remains; and

WHEREAS, the Tribe's self-governing capabilities, political integrity, and our identity as Tachi People will be enhanced and protected by Tachi governmental control, regulation, and preservation of our cultural resources, which are essential for the well-being of the Santa Rosa Rancheria Tachi Yokut Tribe and its future.

NOW THEREFORE, BE IT RESOLVED THAT, the Tribal Council of the Santa Rosa Rancheria Tachi Yokut Tribe supports and nominates Tribal Liaison William (Kenny) Barrios to the CSU Systemwide and Campus NAGPRA Committees.
