A voting member of a California Indian tribe shall be an elder, spiritual leader, tribal leader, or tribal member, as designated by the governing body of the individual's tribe, with a minimum of five years' prior experience in any of the following:

- Repatriation of human remains and cultural items pursuant to federal NAGPRA;
- Cultural resources protection under Tribal, state, and federal law; or
- Consultation with state and federal entities and agencies.

Preference shall be given to members of a California Indian Tribe. If no members of a California Indian Tribe meeting the qualifications of 8028.71 subdivision (c) paragraph (1) are available, members of other Tribes may serve.

#### CSU Nominees

CSU Nominees must be affiliated with or employed by the California State University and have the following:

- A graduate degree in any of the following: Archaeology, Anthropology, Native American Studies, Ethnic Studies, Law, Sociology, Social Sciences, Environmental Studies, or History, with a focus in California
  - If there are no candidates satisfying this clause, candidates that have degrees and direct professional experience in fields relevant to repatriation or tribal cultural resources matters shall be deemed to meet the requirements of the clause; and
- A minimum of five years' experience working in his or her field of study.

Preference shall be given to members who have demonstrated, through their professional experience, the ability to work in collaboration with Native American tribes successfully on issues related to repatriation or museum collection management.

In the event that candidates from the California State University are not available or do not meet the above criteria, the California State University representative positions may be filled by retired emeriti of the California State University who meet the above criteria.

*Whereas;* The Gabrielino/Tongva Nation ratified The Constitution of the Gabrielino/ Tongva Nation on February 17, 2007 and amended the same on February 22, 2020; *and* 

Whereas; The Constitution is the Supreme Law of the Gabrielino/Tongva Nation; and

*Whereas;* Article IV of the Constitution calls for the Peo'tskome (Tribal Council), the elected governing council of the Gabrielino/Tongva Nation, to pass and enact a law for the requirements to run for election and serve as a member of the Peo'tskome; *and* 

*Whereas;* The Gabrielino/Tongva Nation Election Act of 2007 was enacted and revised ten separate instances under the guidance and the power vested in the Peo'tskome pursuant to the Constitution of the Gabrielino/Tongva Nation; *and* 

*Whereas;* The Gabrielino/Tongva Nation Peo'tskome are duly elected through the laws governing the Gabrielino/Tongva Nation; *and* 

*Whereas;* Article V, Section 2F of the Constitution gives the Peo'tskome the power to negotiate or enter into Treaties, Compacts, Contracts, or other Agreements with other governments or other parties on behalf of the Gabrielino/Tongva Nation; *and* 

*Whereas;* Article V, Section 4 of the Constitution gives the Peo'tskome any right or power, heretofore, vested in the Gabrielino/Tongva Nation, but not expressly referred to in the Constitution, shall not be abridged; *and* 

*Whereas;* Article II, Section 2 of the Constitution calls for the Peo'tskome to pass a law creating a Department of Citizenship; *and*

Adam Loya is a citizen of the Gabrielino/Tongva Nation. He has served on the Tribal Council since 2005 and as the Vice-Chairman since 2008. He is a member of the Golden State Gourd Society, as well as a Grass Dancer. He has served as a Head Man Dancer and Arena Director for several powwows in California.

He became involved with Tribal Activism in 1995, when he first spoke to the City Council of Huntington Beach and with the greater Native American Community, gaining a vast amount of knowledge, experience, and understanding.

He is actively revitalizing the Tongva Language and Songs. His preservation efforts are focused on the future generations.

Public Comment, Joe Castillo, representing the Gabrielinos and true California history, public comment on CalNAGPRA committee nominations

Dear sirs,

I am providing public comment opposing the nomination of several candidates to the CalNAGPRA commission.

I am an independent historical researcher and have written five books on California history as well as author of a weekly column on various historical topics in California. I have also performed an extensive and detailed study and research on determining the origins of the Tongva tribe and name. Based on my 1,100-page research manuscript titled "The Evolution of the Tongva Tribal Name", the "Tongva" name was established in 1992 after being "chosen" by the Gabrielino Band of Mission Indians. My research indicates that the "Tongva" name was a self-chosen, self-identified and self-proclaimed tribal name with no ancestral, cultural, or historical association with the Gabrielinos. Over 161 source documents were examined supporting the lack of evidence that the "Tongva" are the native tribal name of the Gabrielinos. Furthermore, the study contacted members of the Gabrielino/Tongva Nation and the Gabrielino/Tongva Band of Mission Indians and all refused to comment on the origins of the "Tongva" tribal name.

As my review indicates the "Tongva" tribe to be an inaccurate, incorrect tribal of the Gabrielinos tribe with no ancestral, cultural, or historical support, then each tribe using the "Tongva" name should also be considered a questionable and dubious tribe with members who may also be questionable and dubious in their genealogical ancestral records. In 1994, the State of California also found no support for the "Tongva" name during the state recognition review process of the Gabrielino tribe and removed the "Tongva" name from the recognition application. Three other subsequent resolutions submitted to the State of California with the "Tongva" name never made it out of committee review.

As the following candidates are associated with "Tongva" named tribes or have been recommended by "Tongva" tribal members, I strongly oppose the nomination of these individuals as they will be compromising the integrity and ethics of the CalNAGPRA Commission and committees:

- CSU Dominquez Hills, Christina Connelly, Gabrielino Tongva Indians of California
- CSU Fresno, Cristina Gonzalez, CSU Native American Studies Member recommended by Desiree Martinez (Tongva)
- CSU Los Angeles, Adam Loya, Gabrielino/Tongva Nation
- CSU Long Beach, Kelley Leah Steward, Gabrielino/Tongva Nation
- CSU Northridge, John Cody Blunt, Gabrielino/Tongva Nation, recommended by Sam Dunlap (Gabrielino-Tongva Nation)
- CSU Channel Islands, Edgar Perez, Gabrielino/Tongva Nation, recommended by Nicholas Rosenthal and Samuel Dunlap (Gabrieliño/Tongva Nation)
