The CSU is referencing the requirements as outlined in Assembly Bill 389 Section 8028.7 and Section 8028.71 to guide the committee selection and policy development processes.

**CSU Nominees:** Support letters or resume for CSU nominees should include professional experience demonstrating the ability to work in collaboration with Native American Tribes successfully on issues related to repatriation or museum collection management.

## QUALIFICATIONS

### Tribal Nominees

A voting member of a California Indian tribe shall be an elder, spiritual leader, tribal leader, or tribal member, as designated by the governing body of the individual's tribe, with a minimum of five years' prior experience in any of the following:

- Repatriation of human remains and cultural items pursuant to federal NAGPRA;
- Cultural resources protection under Tribal, state, and federal law; or
- Consultation with state and federal entities and agencies.

Preference shall be given to members of a California Indian Tribe. If no members of a California Indian Tribe meeting the qualifications of 8028.71 subdivision (c) paragraph (1) are available, members of other Tribes may serve.

### CSU Nominees

CSU Nominees must be affiliated with or employed by the California State University and have the following:

- A graduate degree in any of the following: Archaeology, Anthropology, Native American Studies, Ethnic Studies, Law, Sociology, Social Sciences, Environmental Studies, or History, with a focus in California
  - If there are no candidates satisfying this clause, candidates that have degrees and direct professional experience in fields relevant to repatriation or tribal cultural resources matters shall be deemed to meet the requirements of the clause; and
- A minimum of five years' experience working in his or her field of study.

Preference shall be given to members who have demonstrated, through their professional experience, the ability to work in collaboration with Native American tribes successfully on issues related to repatriation or museum collection management.

In the event that candidates from the California State University are not available or do not meet the above criteria, the California State University representative positions may be filled by retired emeriti of the California State University who meet the above criteria.

Dear Implementation and Oversight Committee,

At the request of the Office of Tribal Relations (OTR), I am submitting my application for nomination as a CSU Nominee for the CSU Native American Graves Protection and Repatriation Act Implementation and Oversight Committee. Over the past five years, I have worked with OTR regarding the revision and implementation of a new partnership between Tribal partners and Chico State. As an archaeologist, my work directly intersects the concerns of Tribal stakeholders in California and beyond, and I have sought to find a workable solution for discipline practice that aligns with the intent of CalNAGPRA and NAGPRA. I have served to facilitate the reburial of university owned collections and as a consultant to OTR in its attempts to return ancestral and cultural items to descendant communities. While I have often been involved with existing collections, my primary emphasis has been centered on how archaeology can become a positive contributor to Tribal interests in cultural resource management.

Over the past five years, I have sought to establish clear lines of communication between my department and OTR to ensure our program provides transparency to help rebuild trust. As director of the Archaeological Research Program (ARP), I manage contracts with various federal, state, and private agencies to meet their cultural resource needs, and I have sought to make this work more inclusive of Tribal students and communities that may want to become involved in archaeology. Over the past two years, I have worked closely with the Kletsel Dehe Band of Wintun Indians of Cortina Rancheria and former Governor Jerry Brown on a project centered on his Rancho Venada. This 2,500 acre ranch is located near Williams, California, and the former governor's family has maintained control of this land since the 1860's. This partnership between Chico State and the Kletsel Dehe has allowed Tribal partners to access land that was taken from them over a century ago, and I have sought to build a collaborative project that identifies Native American archaeological sites with the goal of protecting them into the future. As the former governor seeks to establish a center of learning revolving around the many natural and cultural resources located on the property, Chico State seeks to promote the importance of Tribal history and continuity that has been overshadowed by the more recent Euro-American history. This project has proven personally rewarding and enriching as I developed personal relations with the Chairman and many members of the community, and I believe the project serves as an archetype of what archaeology at the CSUs could become as we realign our discipline with those of Tribal interests.

In addition to the existing collaborative research project at Rancho Venada, I have enjoyed a role in facilitating Tribal requests through OTR. To be honest, I cannot fathom why OTR continues to seek my assistance, because I do not feel that I worthy of such a role. First, I was chosen to do the initial recording of the land on the Big Chico Creek Ecological Reserve before the reburial of repatriated items could occur. The goal of this effort was to ensure that the California Historical Resource Information System (CHRIS) had an existing record of the burial location to ensure future wildfire management and future



development would avoid this location. To be entrusted with knowledge of this location as an archaeologist was humbling and deeply appreciated. Finally, I was approached by OTR to initiate Tribal monitor training for the Maidu Summit Consortium where I would provide basic training of archaeological practices so that they can serve as archaeological monitors or archaeological field technicians. While the purpose of this role is to be an educator, I am certain this experience will provide me with a greater appreciation of the rich history of Maidu culture, traditional ecological knowledge, and their stewardship practices. While this work has yet to begin, I again am humbled by the request, and I look forward to assisting Tribal communities as they seek to take a more active role in the preservation of their past.

As I have mentioned, I did not expect to be solicited by OTR to apply for this role, and I happily acknowledge there are more important people who should serve in this advisory role. I also acknowledge the seriousness of the institutional harm that my department and university played in disenfranchising our Tribal communities across California and beyond. If I am selected, I look forward to furthering my education of needs and wants of today's descendant communities, and I hope to align my discipline to help address them regardless of whether I am chosen for this role. I am foremost an educator, and I intend to take what I learn and incorporate it into the classroom so that aspiring archaeologists understand the gravity and importance of collaborative and inclusive practices regarding the deep and rich cultural heritage of California's Native Americans.
