Re: Action Item 7: CSU Systemwide/Campus and Oversight
Committee Nominations

I. AB 389 REQUIREMENTS

Each of the campus committees shall be comprised as follows:

A. Tribal Members

- 3 Federally Recognized Tribal Voting Members
- 1 Non-Federally Recognized Tribal Voting Member,
 - If no Non-Federally Recognized Tribal Member is available a qualified member of a Federally Recognized Tribe may fill this position.

(Health and Safety Code §8028.71(b)(2))

B. Tribal Member Qualifications

- Must be either an elder, spiritual leader, tribal leader, or tribal member, as designated by the governing body of the individual's tribe
- Must have a minimum 5 years' experience in either:
 - Repatriation of human remains pursuant to NAGPRA
 - Cultural resources protection under tribal, state, or federal law
 - Consultation with state and federal entities or agencies

Preference shall be given to members of a California Indian Tribe. If no members of a California Indian Tribe meeting the qualifications are available, members of other Tribes may serve.

(Health and Safety Code §8028.71(c))

C. CSU Members

- 3 Voting Members from the California State University
- At least one of these CSU members must be affiliated with an American Indian or Native American studies program

(Health and Safety Code §8028.71(b)(2))

D. CSU Member Qualifications

A representative of the California State University shall meet both of the following criteria:

- Have a graduate degree in any of the following: Archaeology, Anthropology, Native American Studies, Ethnic Studies, Law, Sociology, Social Sciences, Environmental Studies, or History, with a focus in California; and
 - **Exception:** If there are no candidates with the above qualifications, candidates that have degrees and direct professional experience in the fields relevant to repatriation or cultural resources shall be deemed to meet the degree requirements.
- Have a minimum of five years' experience working in his or her field

Preference: Preference shall be given to members of a California Indian Tribe and to members who have demonstrated, through their professional experience, the ability to work in collaboration with Native American Tribes.

Retired Emeriti: In the event that candidates from the California State University are not available or do not meet the criteria of paragraph (1), the California State University representative positions may be filled by retired emeriti of the California State University who meet the criteria of paragraph (1).

(Health and Safety Code §8028.71(d))
