- Cultural resources protection under tribal, state, and federal law; or
- Consultation with state and federal entities and agencies.

Preference: Preference shall be given to members of a California Indian tribe.

UC Nominees

UC Nominees must be affiliated with or employed by the University of California and have the following:

- A graduate degree in any of the following: Archaeology, Anthropology, Native American Studies, Ethnic Studies, Law, Sociology, Environmental Studies, or History, with a focus in California; and
- 2. A minimum of five years' experience working in his or her field of study.

Note: At least two UC nominees to the Systemwide one UC nominee to the Campus Committee(s) must be affiliated with an American Indian or Native American Studies program.

You are encouraged to submit a nomination if the nominee meets a majority of the requirements, even if you are unsure as to whether they meet a specific requirement. In the event that you are uncertain as to whether a nominee may be qualified under a certain requirement, please include a brief explanatory statement supporting their qualifications in your nomination packet. Biography of Samuel Thunder Rodriguez Cultural Resource Officer – Costanoan Rumsen Carmel Tribe

Samuel Thunder Rodriguez is a deeply respected Cultural Resource Officer for the Costanoan Rumsen Carmel Tribe, whose life and work reflect a powerful convergence of traditional lifeways, academic training, and environmental stewardship. Born into a lineage rooted in ceremony, land-based knowledge, and ancestral responsibility, Samuel is not only a guardian of sacred sites and cultural materials, but also a practitioner of healing traditions recognized by his community.

Samuel's journey began in the sacred rhythm of tribal life. From a young age, he was immersed in ceremonial cycles that honored the land, the waters, and the spirits of those who came before. Raised among Elders, singers, and ceremonial leaders, he learned not just with his mind, but with his heart—through lived experience, seasonal rites, and the quiet discipline of observation. He was not told who he was; he lived who he was.

At the age of 13, Samuel answered the call to undertake the traditional fasting ceremony—a rite of passage central to his tribe's spiritual tradition. Over four days and nights without food or water, isolated in prayer and guided by ceremonial leaders, Samuel went into the mountains and emerged changed. In that deeply sacred ceremony, he was spiritually recognized and embraced as a bear and a healer Oress ama—one who carries the medicine of protection, introspection, and renewal. This role is not symbolic. It is lived. Samuel walks with the responsibility of healer in his community, tending not only to people but to the land, the elements, and the spirit of place.

With a foundation in tradition, Samuel pursued academic study to strengthen his advocacy in a world shaped by policy, development, and environmental change. He holds undergraduate degrees in Anthropology, Archaeology, and Environmental Science—a rare and potent blend that positions him at the intersection of cultural preservation and ecological responsibility. His academic work complements his ceremonial knowledge, allowing him to interpret cultural landscapes not only through maps and site records, but through the oral memory of the land and its original people.

As a Cultural Resource Officer, Samuel plays a critical role in consultation, (Cal) NAGPRA, site protection, and cultural education. He has served as a Tribal monitor for major infrastructure and conservation projects throughout California, ensuring that ancestral lands are treated with dignity and that Native voices shape how those lands are managed. He works closely with state agencies, archaeologists, and environmental planners—but always from a foundation of tribal sovereignty and Indigenous worldview.

In every layer of his work, Samuel advocates for a holistic approach to land stewardship—where sacred sites are not "points of interest," but living parts of an interconnected system that includes plant relatives, water beings, animal nations, and the intangible energies that dwell in place. He brings ceremony to his work, and his work to ceremony.

Whether leading prayer at dawn over a coastal bluff or reviewing an environmental impact report with a land use agency, Samuel Thunder Rodriguez remains what his ancestors and Elders intended him to be: a bridge between worlds, a protector of sacred knowledge, and a bearer of medicine in a time that deeply needs it.
